The annual breakfast Business Meeting was held March 11, 2011 at Davidson County CC.

Nancy Rivers welcomed the attendees and called the meeting to order at 8:45 am.

Robert Farinelli provided greetings from AMATYC and announced that the next AMATYC conference will be held in Austin Texas, November 10 - 13, 2011. He also informed the attendees of the new webinar series launched by AMATYC last month. Their goal is to have one every month at least through the academic year to extend the conference experience all year round.

Minutes from Previous Meeting -- No minutes were located, the former Secretary went into labor on the way home from the conference.

Reports -

Treasurer – The checking account has a balance of \$7618.70, the money market account has a balance of \$6835.48. The following represent expenditures from 6/24/2010 through 3/7/2011: Board meetings \$1557.28, Newsletter \$598.60, Executive Travel \$992.92, Awards \$1525.74, Website \$1000, Postage \$17.60 and Conference expenses \$375.98. The following represents revenue from 6/24/2010 through 3/7/2011: Conference fees \$700.00, Conference registration \$4680.00 and membership dues \$2540.00.

Membership - We currently have 242 active members including 40 new members.

Student Math League - Last year Central Piedmont won the state award, finished first place in the Southeast region and third place in the country. Wake Tech finished second in the state.

Conference Statistics – There were 131 attendees, 10 vendors, 10 commercial sessions and 39 sessions presented at the 2011 conference.

2012 NCMATYC Conference will be held at Cape Fear Community College in Wilmington March 15th and 16th.

Awards

Faculty Math League – Ten attendees took the Faculty Math League exam. The third place winner, from Wake Tech, was Mary Pearce. The second place winner, from Wake Tech, was Julia Head. The first place winner, also from Wake Tech, was Seth McElvaney.

Mathematics Excellence Award – Lee Ann Spahr was the recipient of the second NCMATYC Mathematics Excellence award. She has attended every NCMATYC conference and 16 of last 20 AMATYC conferences, congratulations Lee Ann.

Travel Awards – One AMATYC and three NCMATYC awards were granted to attend conferences.

Nominations for new board members – New board members will be elected by our next conference.

The 2013 conference will be held in the Western region, we are looking for a commitment for hosting that conference.

Newsletter articles for submission to the fall newsletter are due in to Daniella Zemanek by April 15th.

New Business -

Amendments to the Constitution and By-Laws --- Jean McGinnis made a motion to wave the reading of the proposed by-law changes; the motion was seconded by Glynis Mullins and passed unanimously.

Jeanne McGinnis made a motion to vote on amendments as a block, the motion was seconded by Glynis Mullins. No discussions ensued, the proposed changes passed unanimously. The changes are as follows:

- Section 1, Constitution and By-Law In Section I, Article 7. Officers Section 2. Term of Office, Each officer serves for a term of two years taking office at the board retreat beginning no later than June 1st after the election.
- Section 1, Article 7. Officers Section 4b. Should the President leave office before the expiration of their regular term, the President-Elect will complete the unfinished term as President in addition to his/her term as President-Elect, if he/she decides to resign as President-Elect that position can be filled as outlined in part (a).
- Section 1, Article 7. Officers Section 6c. 5. Must file federal taxes by April 15th of each year.

Acknowledgements – A special thanks was given to Jennifer Comer and her team for all their hard work in pulling off an exceptional conference. Also, special thanks were given to Ann DeBoever for her work on the conference schedule.

The USCOTS conference will be held May $19^{th} - 21^{st}$ at the Research Triangle Park. This conference is NSF funded and provides free preconference workshops.
